

In my many years as first a committee member, and thereafter the President of this remarkable organisation, I am never short of amazed and in awe of the work the Centre does and these amazing people do.



DIRECTOR'S REPORT

This past year was another busy year continuing to respond to the high rates of Sexual and Domestic Violence whilst undertaking significant work that supported the implementation of law reform and policy development, guided by the Women's Safety and Justice Taskforce recommendations.

Throughout this period, the GCCASV team, always managed to prioritise safety and wellbeing through adaptation and flexibility, providing timely and ethical information, support, counselling, healing, and access to justice for victim/ survivors of Sexual and Domestic Violence.

Through our education and training programs, we have been changing the practice of responding to Sexual and Domestic Violence, focusing on awareness in the community and building capacity to improve frontline responses. Through service commitment to the international Start Believing campaign, we have continued to work towards community culture believina of survivors whenever they disclose Sexual Violence.

This year the dire economic situation has impacted the whole community with higher cost of living, mortgages, scarcity of rental properties and increasingly high rents. Many of our clients cannot afford food and/or have found themselves homeless or at risk of homelessness.

This has presented a significant challenge to GCCASV in providing counselling to those living in cars and couch surfing without basic human rights of food and shelter. By working with Housing & Homelessness Services and collaborating with our community colleagues Quest Hotel and St John's Crisis Centre, we have often been able to broker some safer housing options.

Working closely with Queensland Police Service, "Project Engage" has continued to be of great value to our clients. Being able to meet with a female police officer in the safety of the GCCASV building has been a game changer in relation to understanding police processes, providing a pathway to reporting and making a statement, case updates and positive communication. Thanks to all the female detectives who participated in the past year we are appreciative of your attendance at our service.

GCCASV has also provided assistance in designing trauma informed, victim centric rooms at police headquarters to provide safer spaces when attending the police station.

Sustained structural advocacy with both State and Federal governments is really important. This year GCCASV has continued to engage with government and other stakeholders to raise systemic issues of concern and to ensure the voices and experiences of victim/survivors of Sexual and Domestic Violence are considered in the formulation of relevant policy and legislation in Queensland.

GCCASV undertook 25 written and oral submissions, in addition to parliamentary inquiry and consultation participation experiences, at a state and federal level. Along with other Sexual Assault services in Queensland we have also been able to leverage our position through our membership of Queensland Sexual Assault Network (QSAN).

A big thank you to our funders the Department of Justice and Attorney General (CSYW). I would like to pay special tribute to Lisa Eggleton our Contract Officer and Michelle Potter, Integrations Manager who are so helpful and supportive. Thank you.

This past year GCCASV was fortunate to receive additional short-term state and federal government funding. These extra funds have taken some of the pressure off an overloaded staff team, struggling to meet demand, but fail to address how GCCASV can maintain that momentum into the future. We will continue to advocate and lobby for a sustained increase in our CORE FUNDING to provide a safe and stable foundation to strategically plan for the future.

To our Management Committee whose support and strategic guidance provides another layer of governance critical to managing the operational components of our service- we really appreciate your combined expertise and the commitment and time you give to GCCASV on a voluntary basis.

To all of our staff team, thank you for your commitment and the job you do day in day out in a really confronting area of violence against women. Whether you work in administration, in education, in training, in support or in counselling you do an amazing job, and your efforts are much appreciated.

I would like to pay a special tribute to Kellie, our Counselling Manager who has managed an expanded counselling team this year and kept everything running smoothly inside the organisation with her ongoing dedication, flexibility & professionalism.

COUNSELLING



From the counsellors...

We believe that Hope is an important part of the healing process.

Hope is the belief that counselling will help you think, feel, and behave in a more positive way. This may include learning new skills, feeling better about yourself, setting goals, and making sense of your past.

As Counsellors, our role is to facilitate your Hopes, dreams and aspirations. This is achieved through working together at your own pace, in a non-judgmental, respectful and caring format.



COUNSELLING MANAGER'S REPORT

Throughout 2022-2023, the dedicated staff at the Gold Coast Centre Against Sexual Violence (GCCASV) consistently demonstrated their commitment to delivering high quality counselling, support, and advocacy to women, young women and older women who had been subjected to Sexual, Domestic and Family Violence. These services continued to be offered through our two programs; Sexual Violence and Women's Health and Wellbeing.

The counsellors utilised a diverse range of strategies and therapies, underpinned by a feminist framework, to effectively respond to the many trauma responses that significantly affect the day-to-day functioning and overall wellbeing of women accessing the Centre.

These responses were often further intensified by the ongoing accommodation crisis on the Gold Coast, as well as prevalent issues of isolation, limited resources, and the financial hardships faced by many women.

More women are seeking timely support, with over 50% of those in the Sexual Violence program connecting with the Centre within a year of being subjected to violence. It is worth noting, that 35% of women in this program disclosed additional experiences of Sexual Violence.

Further data collected from 2022-2023 revealed that 98% of women seeking support from the Women's Health and Wellbeing Program had experienced five or more forms of abuse or aggravation, with some of these clients having endured over 30 years of violence and trauma.

Due to a consistent demand for services, both the Sexual Violence and Women's Health and Wellbeing Programs once again had waiting lists with fluctuating waiting times throughout the year. Staff worked hard to minimise these lists as much as possible, and to generate ways to increase women's access to support and counselling.

GCCASV consistently offered a diverse range of counselling options, including in person, phone, and online video appointments. Increasingly, women have been opting for online platforms or phone sessions, benefiting from the flexibility and accessibility these options provided.

GCCASV also continued to extend its support and services to women through outreach to schools, courts, and police stations when needed.

While individual counselling remained the cornerstone of GCCASV's services, the Centre also recognises the importance and value of group work opportunities. Group sessions provided a supportive environment for women to connect with each other, reduce isolation and share strategies, often while learning new skills and having some fun.

Group sessions during the last year included movement, creative arts, poster making, nutrition and a Women's Health and Wellbeing event in Domestic Violence Awareness Month. One of the standout sessions was a creative writing workshop led by Anna Mraz, where many women produced inspiring pieces of writing.


Advocating for women as they intersect with other services and systems is another vital task undertaken by staff on a regular basis. During this year, the Centre supported women in their interactions with reporting and legal systems, a range of medical services & practitioners, educational institutions, housing, Domestic Violence services, Centrelink, Child Safety and other services designed to address women's additional needs.

This aligns with the Centre's commitment to engage with other agencies and establish collaborative partnerships, strengthening referral pathways, and ensuring a holistic and comprehensive approach to supporting women in their journey towards safety, justice, and healing.



Meeting with Thriving Multicultural Communities

A significant legislative development during the last year was the introduction of a new reporting requirement, known as Section 229BC. This legislation emerged from the Royal Commission into Institutional Child Sexual Abuse recommendations to improve the reporting of suspected child sexual abuse. In response, GCCASV developed and implemented additional policies and procedures, which ensured compliance while maintaining client agency.



Lunch & Learn on Modern Love Languages

GCCASV staff remain committed to improvement continuous and professional growth. This year, Ana Carrigan was appointed as the external clinical supervisor, providing both individual & group supervision sessions. Supervision sessions that address organisational and administrative issues are provided by myself along with onaoina informal support and debriefina.

Staff also participated in community of practice initiatives and accessed online and in person professional development, with the information learnt often shared with the team in regular 'Lunch and Learn' sessions.

There were a number of staffing changes this year with Sarah, Jade, and Irene joining the team. Rana, a valued member of our counselling team went on maternity leave, and Toni left to explore new opportunities.

I would like to express my gratitude to the whole GCCASV team and thank them all for the support they provide to me personally. I also commend them on the amazing work they do, with the women who access our Centre and the wider Gold Coast community.




SERVICE OVERVIEW



In both programs the majority of service users were victim/survivors who were assaulted on the Gold Coast.

















Location of the Sexual or Domestic Violence 11% Rest of QLD 72% GC 12% Interstate







I have been completely surprised and touched by the space that you have fostered. I initially had reservations about coming to a place with a name that so clearly spoke to the why of my need to attend. I felt ashamed, embarrassed and doubtful that there could be any service that might be able to help....I guess the point is; is that I was/ still am in trauma and have been so traumatised by the process of reaching out for help with protective services, that I felt very doubtful and suspicious that a community service could make any difference. I felt it was safer to suffer on my own, than risk attending any institute.

However, after avoiding coming in for months, I finally spoke to someone on the phone and she spoke to my concerns around confidentiality and provided the assurance I needed that I would be in a safe and confidential space with a counsellor. And from the first moment I arrived at the 'house' with my kids, I felt such a strong energy of warmth and comfort and of dignity. It was not as I feared, but the opposite. The space is infused with dignity everywhere, which I realise now, is what my heart was longing for. My children were welcomed and invited to enjoy whatever snacks they liked, given the opportunity to colour or play games and permitted to sit in such a colourful and safe environment, that it allowed me to relax and focus on myself when my session occurred. For this I am very grateful. There was no stigma. The boys even had a good time while waiting, and they were fussed over at exit, being invited to take any little supplies that might be helpful. They don't know the name of the place or why we were there (specifically) but they have asked about returning again.

And the vibe continues throughout all aspects of the service it seems. From front reception, to the brightly dressed and smiling workers I've passed on the stairs, to the warm and safe room of the counsellor's office, I have been blown away by what you offer. I have had 3 visits and each time, I have walked away with little and big gifts of goodwill, including a safety device, (which meant so much at this time) and more importantly I have walked away with a slightly straighter back, a spring in my step and sense of warmth and hope in my heart- LF

A Book of Hope

Several years ago, a client's feedback gave the GCCASV team a reason to pause and reflect. Whilst we had many resources available to share information on trauma and healing, the client wanted and needed something else- Hope.

This feedback prompted the development of the first edition of the Book of Hope, which was filled with activities and inspiration to empower survivors and remind them that they are more than their trauma.

FEBRUARY 2023

Di went to Tasmania with the Red Rose Foundation and presented on Sexual Violence and Strangulation to Tasmanian Government workers

Brave conversations were had on all aspects of Sexual and Domestic Violence at a weekend workshop at the Slacks Creek Mosque, with Di presenting alongside Yasmin Khan from The Bangle Foundation.



MARCH 2023

Kellie and Kerrin provided training to School Based Youth Health Nurses on supporting young people with disclosures and reporting.



ROCKHAMPTON - FEBRUARY 2023

In February, Kellie and Kerrin spent time in Rockhampton delivering training to the wonderful team from Women's Health Information and Referral Service CQ Inc. It was an amazing two days exchanging knowledge and ideas with other professionals who shared a passion for women's wellbeing and rights.

ELSA TRAINING - AUGUST 2022

To acknowledge the hidden and serious nature of Elder Sexual Abuse (ELSA) and to address the identified gap in service delivery for victim/survivors, Di and Kerrin once again delivered the innovative specialised two-day training program "Recognising and Responding to Elder Sexual Abuse". Held at the Park Regis Brisbane in August, the training was well attended by a broad crosssection of professionals including police, Sexual, Domestic and Family Violence workers, social workers, vouth workers, community organisation representatives, redress scheme workers, and phone respondents.



HOMELESSNESS FORUM - AUGUST 2022

GCCASV was invited to contribute to a panel at the Lady Musgrave Trust's 14th Annual Forum on Women and Homelessness. speaking Kerrin attended. the intersection of Sexual Violence and homelessness. This panel was an opportunity to highlight the issues faced by women subjected to Sexual Violence and the additional complexities for older women as the fastest growing cohort of homeless.





Through 2022, Kerrin continued her involvement in the delivery of Intimate Partner Sexual Violence training in the ISACURE course at Queensland Police Academy.

SCHOOLIES TRAINING - SEPTEMEBER 2022

To increase the reach of our training of Safer Schoolies Response staff and volunteers, Kellie and Kerrin recorded two training videos this year. Focusing on Responding to Sexual Violence in the Schoolies precinct, and Bystander Interventions for interrupting harm, the videos were incorporated into compulsory training modules.

The quality of the videos and content was reflected in them later being incorporated into the school-based Schoolies education sessions.

This forum was delivered using a hybrid in-person and online format to nursing & medical professionals, multidisciplinary healthcare providers, as well as internal and external partners of Queensland Health.
















Sexual Violence Awareness Month

DIGITAL SUPPORTERS KIT

This year we were fortunate enough to be able to pursue an in-person events calendar.

OPPORTUNITIES

Whilst there was a huge increase in social media visitors, the audience was relatively homogenous across both platforms and stable compared to last year. Facebook was 92% female, predominately aged 35-55years, and Instagram was 91% female, with a slightly younger demographic 25-34years. This is also reflective of our client base and presents both a challenge and opportunity in engaging cis men of all ages to help raise awareness of Sexual Violence.

START BY BELIEVING COMMUNITY BREAKFAST

The 'Start By Believing Community Breakfast' was held on 5th October at Sharks Function Centre.

We were delighted to have over 200 individuals attend the event, demonstrating their support for our agency. The breakfast featured exceptional speakers who presented on the theme of 'Help, Hope, Change', including Kelly Humphries, Caroline Bellenger, Di Macleod, Kellie Wilk, and MC Narelle Poole.

The event was further enhanced by the live performance of Tayla-Lee Music, whose music centres on promoting women's empowerment and driving social change. Attendees participated generously in the raffle, which included an array of exciting prizes, ranging from pampering packages and gift cards to dining experiences and accommodation vouchers. We express our gratitude to all who contributed to this successful event.

RECLAIM THE NIGHT

An exciting addition to this year's SVAM calendar was the reinvigoration of Reclaim The Night. After a 17 year hiatus, we ran a small test event to see if there was local interest. The support from Queensland Police Service and Gold Coast City Council to use The Porch Stage at Broadwater Parklands was invaluable.

A small but dedicated group of 50 women, children, and supporters showed up in solidarity and to listen to performances by Tayla-Lee Music (singer/songwriter), Georgia Hoareau Music (singer/songwriter), and Anna Avocado (spoken word poet).


The feedback from all who attended was overwhelmingly positive with many clients commenting on how empowering they found the event and the permission to yell and be angry in public. The experience of Reclaim The Night has provided a solid foundation and momentum for next year's event.

Getting Where You Need To Go

Safer transport for victim/survivors of Sexual and Domestic and Violence and their children






Women have experienced greater safety and decreased stress by accessing the program

Children have been positively impacted by purchases and repairs made by mothers accessing the program

This year, the pilot for the "Getting Where You Need To Go" project ended. Due to the success of this pilot, we were able to launch the program with a \$108,000 grant through the James Frizelle Charitable Foundation, to be paid over the next 3 years.

Since the pilot's inception, the number of requests for assistance have remained steady. However, over time the requests received were for higher amounts of aid. The worsening economic situation compelled many women to prioritise paying for increasing daily living expenses over minor car repairs, leading them to take risks by driving unreliable and unsafe cars. These minor repairs eventually led to the need for major repairs. In other instances, some women had reliable cars but lacked funds for petrol.



The outcomes and benefits for women have been achieved through big and small items.



In 2022 GCCASV staff and clients contributed to the Independent Commission of Inquiry into Queensland Police Service responses to Domestic and Family Violence. This inquiry shone a light on the issues in the system. However, it also highlighted the opportunities to advocate for systems change. GCCASV has since contributed to discussions at the Gold Coast Police Sexual Violence Business Unit Review (BUR), and ongoing consultation in regard to the Sexual Violence Response Strategy (SVRS).


GCCASV client engagement with Criminal Justice



FORENSIC EXAMINATIONS

GCCASV made a submission to the DNA Forensic Commission Of Inquiry and provided significant input into the Sexual Violence victim/survivor notification & engagement strategies post inquiry to ensure trauma informed practice was at the core of the response.

Of clients sexually assaulted in the last 7 days, 60% underwent a forensic examination.



TRAUMA INFORMED SPACES

Throughout the year, Di provided consultancy to the South East Region in the implementation of trauma informed interview spaces in the Surfers Paradise HQ. Discussions covered a wide range of environmental considerations from the colour of the furniture to the location of resources.


